 - *If the cancellation occurred with less than 7 days from the departure date: No refund.*
3. The prices quoted in our any printed material or any electronic media (www.communitytrek.com) are subjected to change. For payment we accept Cash, bank transfer or Credit Card (subjected to charge certain percent decided by authority).
